- 3. The gates shall be mounted onto flat topography and are available in configurations to suit either surface mounting onto hard surfaces or embedding within concrete foundations placed in the ground. Furthermore, the local ground onto/into which the gate is installed shall offer compatible strength.
- The gap between the bottom of the gate leaf and the ground must not exceed 50 mm.
- 5. The gates are compatible with the equivalent height fencing systems covered by the scope listed on LPCB certificate 1745j (Issue 01).
